Appellate: \$148.00 per hour

Felony Witness Representation: \$148.00 per hour

Private Investigators: \$85.00 per hour

NOTE: If at any point in the proceedings, charges are changed to a different case type, the hourly rate of compensation will be changed accordingly from that point forward.

Please be advised that the San Francisco Superior Court has authorized an hourly rate increase for all court-appointed counsel in criminal proceedings effective July 1, 2023. Court-appointed counsel will now be compensated at the following rates:

Misdemeanor	\$110	\$122
Regular Felony	\$133	\$148
Serious Felony	\$148	\$164
Investigator	\$75	\$85
