## Justice & Diversity Center Honors Outstanding Legal Services and Diversity Educational Program Volunteers

**April 18, 2014 -- San Francisco** – The Justice & Diversity Center (JDC) of The Bar Association of San Francisco (BASF) celebrated its most outstanding volunteers at its annual Appreciation Celebration on April 17.

More than 250 people attended the event, held at the Louis B. Mayer Lounge at UC Hastings College of the Law. JDC honored volunteers of its legal services and diversity educational programs.

Guest of honor Associate Justice Carol Corrigan, Supreme Court of California, provided inspirational remarks at the awards ceremony and greeted awardees. JDC Board President Stephanie Skaff, Farella Braun + Martel, also made remarks and congratulated awardees.

JDC honored the top 15 percent of the volunteers in its Pro Bono Legal Services Program, Homeless Advocacy Project, and Diversity Educational Programs with Outstanding Volunteer in Public Service Certificates. JDC also recognized four individual volunteers and a law firm with special awards.

Christopher Emley and Don Emley, of the Emley Law Office, received the 2013 James P. Preovolos Award for Outstanding Pro Bono Services in Family Law. Christopher Emley was instrumental in creating the Volunteer Legal Services Program, which later became JDC. He has represented, consulted and mentored in 98 JDC cases. Christopher Emley's son, Don Emley, has also provided pro bono representation in numerous JDC cases since joining the practice in 2011.

JDC presented the 2013 Housing Justice Award to Rudy Balderama of the Balderama Law Firm. He has volunteered with JDC's Eviction Defense project since 2005, and in 2013, represented low-income tenants in seven unlawful detainer cases. Coblentz Patch Duffy & Bass received the 2013 Outstanding Law Firm in Public Service Award. The firm was the second to sign onto JDC's Right to Civil Counsel Pilot Program, and in 2013, the firm's attorneys volunteered on behalf of low-income tenants, consumers and taxpayers. In addition to its pro bono legal services work, in 2013, Coblentz also sponsored one of JDC's Bay Area Minority Law Students Scholarships, a \$30,000 three-year commitment, and hosted a reception introducing the scholarship recipients to their donors.

JDC gave the 2013 Community Service Award to Noemi Gonzalez for her exceptional commitment to pro bono work. Gonzalez volunteers as an interpreter with JDC in numerous family law, eviction defense and consumer matters, and steps in at the last minute for landlord-tenant trials when necessary.
