BASF/JDC Statement: End Trump Policy that Targets Parents and Sponsors of Unaccompanied Children

September 18, 2017 -- San Francisco -- The Bar Association of San Francisco (BASF) and the Justice & Diversity Center (JDC) condemn the Trump Administration's policy targeting parents and sponsors of unaccompanied minor children – overwhelmingly children fleeing gang violence in their home countries and seeking safety in the United States - as cruel and morally reprehensible.

Whether documented or undocumented, the parents, guardians and/or sponsors of these children often provide shelter, care, protection and comfort to their traumatized children. The arrest and incarceration of parents and sponsors who are not charged with any crimes makes absolutely no sense from a human or a policy standpoint. It subjects the children and parents and sponsors to continuing trauma, and it is unjust, unnecessary and costly, wasting thousands of taxpayer dollars to house the children and detained parents while lengthy immigration proceedings wind their way through the courts. Further, there is a realistic likelihood that the heightened fear generated by this policy will drive these extremely vulnerable children directly into the hands of predators and human traffickers for protection.

In addition, we believe that the practice of forcing children to unwittingly provide information which can lead to a parent's or close relative's arrest amounts to cruel psychological abuse of the children. Under this policy, the United States government engages in the use of children as bait with the clear intent of targeting and punishing parents. This practice is a continuation of the administration's effort to deter refugees from seeking protection by punishing innocent human beings – children, mothers and fathers - who are fleeing violence and seeking safety.

Local attorneys, including those working with the JDC Immigration Legal Defense Program, continue to provide needed representation to children who have been arrested and denied entry pending asylum hearings as well as parents and sponsors who have been detained by Immigration Customs and Enforcement. We commend and are proud of the attorneys who have and continue to represent these targeted children and families.
